Rebuild Upstate completed 209 projects at 133 homes during FYE 8/31/16. These projects included 4 electrical repairs, 4 HVAC repairs, 2 roof patches, 79 ramps built, 15 roof replacements, 7 plumbing repairs, 9 grab bar installations, 22 flooring replacements and 67 assorted other projects. As a result of this work, almost 400 residents of Anderson, Greenville, Oconee, and Pickens Counties were left better off than they were before with safer and more accessible homes.
