WE ENVISION AN UPSTATE WHERE EVERYONE HAS THE OPPORTUNITY TO LIVE A LIFE OF DIGNITY IN A SAFE HOME ENVIRONMENT IN ORDER TO MAINTAIN AND FOSTER STRONG, SUSTAINABLE COMMUNITIES. UNLIKE ORGANIZATIONS THAT FOCUS ON NEW CONSTRUCTION, REBUILD UPSTATE REPAIRS EXISTING SUBSTANDARD HOMES TO ENABLE FAMILIES TO KEEP THEIR MOST AFFORDABLE HOUSING-THE HOME THEY ALREADY OWN.
